ii. Election of the President-in-Chief

(Please refer to Article 44 (i) & (ii) of the Memorandum and Articles of Association of The All-India Anglo-Indian Association.)

iii. No person shall be eligible for election to the office of a member of the Governing Body at the Annual General Meeting unless he has, at least eight clear days before the meeting (exclusive of the day on which the notice is served, but inclusive of the day for which notice is given), delivered at the Administrative Office of the Association or sent to the official email ID, a scanned notice in writing, duly signed, signifying his candidature for the office, which is duly proposed and seconded by members of the Association. *(Please refer to Article 52 of the Memorandum and Articles of Association of The All-India Anglo-Indian Association.)*

iv. A member entitled to attend and vote, is entitled to appoint another member who is also entitled to attend and vote, as his proxy to vote instead of himself. *(Please refer to Articles 37, 38, 39, 40, 41, 42 and 43 of the Memorandum and Articles of Association of The All-India Anglo-Indian Association.)*

v. The instrument appointing a proxy shall be deposited at the Administrative Office of the Association not less than seventy-two hours before the time for holding the meeting at which the person named in the instrument proposes to vote and in default the instrument shall not be treated as valid.
